Dear members

Hello again. I trust this newsletter finds you in good health and spirit, and will further whet your appetite for the 2012 NZARES Conference. It's not a bad idea to start thinking about papers now, as a section below challenges you to do.

### AARES conference 2012

The annual conference of the Australian Agricultural and Resource Economists Society took place on 7-10 February in the historic seaside town of Fremantle about half an hour train ride from Perth. Dr Brian Bell represented NZARES as President-elect. Brian had the honour of presenting the two awards to members mentioned in the last newsletter.

The conference was well run with several high profile speakers in the plenary sessions. There were eight contributed paper sessions running concurrently offering something for everyone. For details on the conference see <http://www.aares.org.au/>. A session on the mining boom was particularly eye-opening. The boom is expected to last another 50 years, and interestingly 80% of mining is funded by non-residents. With mining concentrated in WA and Queensland a dual economy has appeared with strong growth in these States while the others tread water. Based on the presentations, Brian noted that he saw no way for New Zealand to bridge the GDP per capita gap – it will just keep widening.

**Perhaps mining is something we could explore further at our NZ conference? It could deliver significant value to NZ, but do the environmental and safety risks (as highlighted by the Pike River tragedy) outweigh that opportunity? Can mining be achieved sustainably in NZ? What do you think?**

There is already a lot going on in the resource policy area in 2012. An overriding driver is the belief that NZ can achieve economic growth while also being proper stewards of our environment. The Green Growth Advisory Group recently released their report which points to the need for a broad growth strategy where all sectors take into account their environmental performance rather than focusing on a few green industries. The Land and Water Forum is also due to report back soon on governance and setting limits on water resources.

The government is also calling for more science-based decision making. Economics is a science. You are all in position to bring forward some well-reasoned and timely arguments that both support and challenge the direction of travel from these and other forums. So find some time to track these reports on the web and develop your thoughts as we lead up to NZARES Conference 2012.
