1. Minutes of the 2017 AGM

2. Matters arising from 2017 minutes

3. Life membership nomination

It was noted that the 3-year sponsorship agreement with the Ministry for Primary Industries concluded this year.

5. Treasurer's Report

It was noted that the Society is in a sound financial position. There was a general discussion about possible ways of increasing expenditure in light of this, as summarised below.

- Prizes, awards and grants:
 - o increasing the value and/or number of them,
 - o provide awards for attendance to other conferences (e.g. US or UK),
 - o making general members eligible, not just students (e.g. through Early Career or Young Professional awards),

- reviewing eligibility criteria with a view to awarding the maximum number of prizes each year,
- allowing universities to nominate more than one candidate,
- allowing students to self-nominate,
- publicising awards directly to students (e.g. through Facebook, posters, scholarship registers) to increase interest and participation,
- considering awarding prizes earlier in the year and advertising them for longer to increase participation;
- subsidising conference costs;
- subsidising student registrations (if not presenting papers);
- organising other events throughout the year.

It was suggested the incoming committee could consider and progress these ideas.

6. Election of Officers and Committee for 2018/19
